At Brockton CE Primary School we have very small numbers of pupils eligible for Pupil Premium funding. This enables us to provide very flexible and bespoke support, individual to each pupil's needs at any given time. This can include financial support for educational trips and visits, curriculum enhancement events and music lessons. Costs of provision of IT devices is also supported if required. Circumstances of individual families are taken into account when making decisions on allocating Pupil Premium funding towards these types of costs for individual children.

Pupil premium strategy outcomes
